Professional Experience

Since 2023 to the present,

Following participation in an internal selection process at the Reggio Emilia Local Health Authority (Azienda USL), I have been deemed eligible to hold the teaching position in Psychodynamic Therapy within the Psychotherapy course.

From 2015 to Present

I supervise clinical cases for Adult and Developmental Psychologist Analysts in training at the Italian Center of Analytical Psychology (CIPA) and for specialized trainees of the psychotherapy school of CIPA.

From June 2010 to Present

I participate in establishing the Emiliani Seminars together with colleagues from CIPA. The Emiliani Seminars have been held since June 2010 on a monthly basis with the aim of creating a platform for experiences for CIPA members operating in geographically decentralized areas compared to the Milanese Institute.

From 2006 to Present

I am the head of the alcohol team at the SerDP, where I engage solely in clinical activities including psychotherapy, psychodiagnostic assessment, and the development of integrated therapeutic projects for patients with Alcohol-Related Problems. I also provide coordination and supervision to colleagues in the alcohol team (2 toxicologist doctors, one psychiatrist, a social worker, and a professional educator).

From January 2010 to Present

I choose a non-exclusive relationship (extramoenia) with the AUSL of Reggio Emilia and open a private practice where I practice as a psychotherapist and psychoanalyst for adults and adolescents.

From February 2002 to Present

I am employed indefinitely as a Chief Psychologist in Psychotherapy at the AUSL of Reggio Emilia. I work at the Substance Abuse Service (SerDP) in Reggio Emilia, where I have been involved in psychodiagnostic assessment and treatment of alcoholic and drug-addicted patients in prison since the beginning of my public service commitment. I have also concurrently engaged in private psychotherapy practice until 2010.

From January 2001 to September 2001

I had an 8-month fixed-term contract with the AUSL of Reggio Emilia as a Chief Psychologist in Psychotherapy, specifically working at the Substance Abuse Service in Reggio Emilia, dealing with psychodiagnostic assessment and treatment of alcoholic and drug-addicted patients in prison as well as in low threshold environments.

From September 2000 to September 2003

I had a freelance contract with the Provincial Administration of Reggio Emilia to coordinate research within the project "Work – Discomfort." The three-year research investigated substance abuse (licit and illicit) among workers in Reggio Emilia.

From February 2000 to December 2000

I had a freelance contract with the Substance Abuse Department of the AUSL of Reggio Emilia to conduct research expert activities for a total of 200 hours, aiming to initiate activities in two companies in the Reggio Emilia area within the "Work Discomfort" project using Action Research methodology.

From October 1999 to December 2000

I had a freelance contract for 38 hours per week for 15 months with the Municipality of Reggio Emilia to develop and coordinate social prevention initiatives.

From October 1999 to January 2000

I taught as an expert psychology teacher at the State Professional Institute for Social, Commercial, and Tourist Services "Don Zefferino Iodi" for a total of 32.5 hours.

From May 1998 to January/April 1999

I taught as an expert psychology teacher at the State Professional Institute for Social, Commercial, and Tourist Services "Don Zefferino Iodi" for 10 hours in May 1998 and a total of 46 hours from January 1999 to April 1999.

From January 1998 to December 1998

I had a freelance contract with the AUSL of the Reggio Emilia District to coordinate, train, and supervise the project: "Building opportunities for self-help among HIV-positive drug addicts."

From November 1997 to June 1999

I had a freelance contract for 20 hours per week for 14 months with the Municipality of Reggio Emilia to coordinate a research-intervention on the use of licit and illicit substances and urban safety in the city of Reggio, including a focus on the world of work.

From October 1997 to December 1997

The below-mentioned contract was renewed (see August 1995 – November 1995).

From March 1996 to February 2002

I worked as a self-employed clinical psychologist and psychotherapist in a practice I initiated.

From February 1996 to May 1996

I had a freelance contract with the AUSL of the Reggio Emilia District for 35 hours per week to continue previous activities and to work in the field of chronicity, providing direct intervention to patients and their families, as well as supervision and support to operators.

From August 1995 to November 1995

I had a freelance contract with the AUSL of the Reggio Emilia District to conduct training and supervision within the project "Training and establishment of a nucleus of informal operators for the engagement of situations at risk of HIV virus spread."

From May 1995 to August 1995

I had a quarterly freelance contract with the AUSL of the Reggio Emilia District for 14 hours per week to provide psychological support to HIV-positive patients and AIDS patients.

From February 1994 to February 1995

I participated in Civil Service at the SerT of the AUSL of Reggio Emilia.

Education

July 1993

I graduated in Psychology - Clinical and Community Psychology track - with an experimental thesis on the relationship between social support and health in adolescent subjects at the University of Padua with a score of 110/110. The study is the result of research conducted at the "Open G" Youth Counseling Center in Reggio Emilia.

July 1999

I obtained a specialization diploma from the School of Specialization in Clinical Psychology at the University of Florence with a score of 70/70 with honors.

March 2009

I completed psychoanalytic training at the Italian Center of Analytical Psychology (CIPA), Milan institute, and obtained a Diploma in Analytical Psychology and acquired the qualification and rights of Analyst Member (title valid as Specialization Diploma in Psychotherapy).

Training

From June 2015 to November 2016

I collaborated on the conception and realization of the show "Maintenance of Dreams: Tribute to Federico Fellini" alongside colleagues from Cipa: Andreoli R., Baldan D., Greco E., Ceroni P., and Gentili A. The performance was created on the occasion of the fiftieth anniversary of the founding of the Italian Center of Analytical Psychology.

From February 2011 to May 2015

I contributed to the organization and participated as a speaker in the four-day study sessions prepared by the Emiliani Seminars under the title: "The Analyst (Jungian) in Play." The subtitle of the first two days held in Bologna on December 4, 2011, and February 25, 2012, was "Thoughts on the Dissociability of the Psyche and Chaotic States of the Mind." In the second day, I presented a paper titled "Dreaming Freely: Analytical Thoughts on the Clinic of Addictions" and conducted the subsequent workshop with Dr. Andreoli. The third study day took place in Bologna on September 21, 2013, with the subtitle "Dizziness of Feeling: Empathy and Dissociability of the Psyche." The fourth study day was also held in Bologna on Saturday, May 23, 2015, titled "Narrating Change: Health and Illness between Theory and Clinical Practice." On that day, I served as a discussant with one of the morning speakers.

From 2012 to 2017

I participated in a supervision group for SerT and CSM operators at the USL of Reggio Emilia aimed at patients diagnosed with borderline personality disorder and conducted by Dr. Antonello Correale, SPI psychoanalyst. The frequency was bimonthly.

From 2011 to 2015

I participated within the institution in a supervision group for cases involving double setup SerT (Service for Dependencies) - CSM (Mental Health Center), led by Dr. Raffaele Fischetti, individual and group psychoanalyst (founder and president of the Research Group in Operational

Psychoanalysis - GRIPO, member of the International Association of Couple and Family Psychoanalysis - AIPCF), with bimonthly frequency.

From 2009 to 2011

I participated within the institution in two supervision groups, both led by Dr. Fischetti, with monthly frequency. One group focused on understanding and studying institutional dynamics in the work group, while the other type of meeting was supervision for clinical activities.

In May 2010

I participated as a speaker at the Conference: "Psychopharmacology and/or Psychotherapy in Common Psychiatric Disorders" with a presentation titled: "Mr. M's Anxiety: Use of Psychoanalysis in the Healthcare Institution."

I attended two update courses managed by the USL of Reggio Emilia for a total of 15 and 27 hours on the theme of "The Clinic of Substance Abuse - Psychotherapy with Drug Addicts."

I was a speaker at the Third European Conference of Addiction Operators.
